## **Health and Wellness Project Intentions**

**WELLINGTON (PEI) – October 8, 2013** – Within the framework of the new Roadmap for Canada's Official Languages 2013-2018 (Health component), a call for project proposals in the areas of health and wellness will soon be issued by Health Canada or Société Santé en français (SSF). The PEI French Health Network (PEIFHN) is therefore inviting groups and organizations from Prince Edward Island to submit a project intention by October 18, 2013.

The PEIFHN is taking this measure to get a better idea of the health and wellness project ideas brewing on Prince Edward Island to increase access to quality French language programs and services for the Acadian and Francophone population of the province. The purpose is to stimulate discussions on initiatives in the areas of health and wellness.

It is important that groups who intend to prepare a project intention take into consideration the parameters prioritized by Health Canada, which provides funding to the SSF and the PEIFHN, including the parameters on target populations and issues such as seniors and access to services for people with mental health issues or people in remote communities as well as the low concentration of Francophones.
